Covid-19 Using clubhouse locker room/toilet/shop	Members could be harmed on entry/exit at clubhouse Members not sticking to 2 metre rule.	Members to clean hands with anti bacterial sanitizer on entering/leaving clubhouse/locker room (Club will have sanitizer in place at entry/exit points) Main access door and exit door from locker room to be kept open to prevent members contaminating keypad Members to follow the one-way system whilst in locker room. No entry to bar area/Lounge/Toilet facilities at all times till restrictions lifted Members to Note once their golf equipment removed from Locker room no further entry allowed to locker Room till further notice. Signs to be fitted to locker room doors to read "Please knock and wait if locker room if occupied stand back at 2metres till free to enter" Only one person allowed in shop and has to maintain the 2 metres rule at all times	Sanitizer bottles to be at entry/exit points prior to club commencing golf All signs and 2 metre markings to be in place prior to golf course being opened	Committee	Immediately

Covid-19 Playing golf	Members not sticking to 2 metre rule	<p>Once members ready to play they must immediately commence to the first tee and not congregate with other golfers When teeing off, other players must be 2metres from opponents</p> <p>All bunkers will be classed as unplayable due to no rakes allowed. No penalty shot, ball to be dropped as near to point of entry No flag poles to be removed at any time and cups will have foam type material to prevent ball dropping fully in hole. Members to retrieve own ball only. Golfers will not handle any of their partners golf equipment including golf balls. On completion of game no handshakes allowed and golfers should return to car park using shortest route and leave car park within 15minutes taking all golf equipment home to save entry to locker room NOTE: Members will be able to submit score for competitions at the computer at entrance to bar, there will be sanitiser next to computer so please sanitise after imputing score and if all members can please adhere to 2mt rule and if busy please wait till first member has updated his score, then next member enters. Members to mark own score in Marker column and partners score in the "A" box. If club house closed on completion of round please put under the shop door. Cards must be signed by member.</p> <p>NOTE: Where golfers are required to travel up to five miles across a local authority boundary, players will be required to adhere to informal exercise guidance which is subject to household limits of 4 players from 2 households.</p>	<p>Green staff to inform committee if anybody not following rules.</p> <p>All members to maintain 2 metre rule if other players ball lands near them.</p> <p>All members to follow this risk assessment which will be posted on main door of club.
